This document describes how the operator of the website www.yogaamani.com (hereinafter referred to as the “website” or “we”) processes the personal data of visitors, clients and service users.

1. Who is the controller of personal data?

The controller determines the purposes and means of processing personal data.

2. What personal data do we process?

We only process data that you voluntarily provide or that arises from the use of our services.

a) Contact forms

name and surname

email

phone (if required)

message text

b) Course / service / membership orders

name and surname

email

phone

billing data (ID, VAT number, address)

order and payment data

c) Newsletter

email

name (if required)

d) Cookies and analytical tools

IP address

device and browser information

website behavior (visits, clicks, pages viewed)

3. Purposes of personal data processing

a) Provision of services and order processing

Processing is necessary for the fulfillment of the contract (e.g. course registration, delivery of materials, invoicing).

b) Response to an inquiry or question

Processing is based on legitimate interest or your consent.

c) Sending newsletters and marketing communications

Only on the basis of your consent, which you can revoke at any time.

d) Improving the website

Using cookies and analytical tools, we monitor website traffic and usage.

e) Fulfilling legal obligations

Accounting, tax documents, archiving.

4. Data retention period

Order data: **10 years** (according to legal obligations).

Contact form data: **1 year**.

Newsletter: **until unsubscribe**.

Cookies: according to your browser settings (typically 30 days - 2 years).

5. Transferring personal data to third parties

We can only share data with verified processors:

web hosting provider,
e-mailing platform,
accountant,
payment gateway provider,
analytical services (e.g. Google Analytics).

We never transfer personal data to third parties for their own marketing.

6. Cookies

The website uses cookies for:

basic functionality of the website, traffic measurement (Google Analytics),
- marketing (if used, Facebook Pixel, ads).

On your first visit, the website will display a cookie bar where you can choose which cookies you want to allow. Technical (necessary) cookies cannot be disabled.

7. Your rights

You have the right to:

request access to your data,
request correction of inaccurate data,
request deletion of data (unless it is contrary to the law),
withdraw consent to processing,
file a complaint with the ÚOOÚ (Office for Personal Data Protection).

8. Data security

We protect your data using technical and organizational measures: - encrypted connection (HTTPS) - limited access to administrator accounts - secure hosting.
